I apologize for the delay getting back to you. We believe we will need to obtain a conflict waiver from the Woodsville Fire District to represent the Board with respect to the issue we discussed. We don't currently foresee any direct conflict between the Selectmen and the Fire District with respect to the issue, but as it may potentially impact the pending litigation, we believe it safer and more conservative to address the issue up front. I left a message for the District's attorney and will follow up with him.

I propose to include my partner Eric Maher in our discussion. Eric is a municipal lawyer with experience of similar issues, and he would add significant value to the matter.
