Old Business

Cybersecurity: Administrator stated that she would be attending a conference in July at Primex Headquarters, in Concord

Unregistered Vehicles: Letter was sent to the Town of Haverhill administrator. No response to date. Doug would like send the letter to the Chair of the Board. (Heard nothing from the town) Mike suggested we cc the PD in the email

Putnam residence water smell: Table it for now. No one has heard back from them.

New Business

Treasurer's report presented by Barb Dutile. Unanticipated Funds \$28,680.22 / Water Account \$15,582.09 / Donations \$3,167.66 / Building Account \$118,436.53. Motion to approve as print by Mike Lavoie. Second by Albie Estes – all in favor Barb presented the Bar Harbor Wealth Management statement as well. No significant changes as it was the April Statement.

Water at Cemetery: Mike Lavoie spoke with Tom Mayo with the cemetery commission. They don't want the water on because of several leaks. The cemetery commission has to repair several leaks. The water is presently off at their request.

Planning Board: Sherri Tice presented Catherine and Jim Bullock as candidates for the planning board. Catherine asked if the decisions the planning board makes are based on the State of New Hampshire laws. Doug Dutile confirmed that was the case. Albie Estes asked if they were ready for the planning board since they are recent residents. Catherine stated that she has done a lot of research on the area. She thinks they would be good stewards of the common. Mike Lavoie asked questions about the last public hangings in New Hampshire (jokingly). Discussion. Sherrie spoke about the planning board. Doug asked Peter Tice rather or not he had any questions. Peter discussed the sensitivities to the area and the value of what is here. Catherine mentioned another prospective planning board member. Justin Tice is interested in being on the planning board and is asking to be a candidate as well. Doug asked Peter about the planning board minutes. Peter said that he had more to go through, but he should have them to me (administrator) by the end of the month. Doug asked Jim for his number so that he may contact them regarding a decision.

The Dipierios are just present to listen to the meeting.

Other Business: Doug Dutile sent the police chief an email asking for an update on the electronic speed limit sign. Mike Lavoie explained that we were only given one sign, which will be placed at the north end of town on route 10. Discussion.

Commissioners reviewed a building permit for the Pekkula property. They need more information before signing off.

Barb Dutile presented notes regarding our loan with Woodsville, which should be paid off by next March. Discussion about paying of the USDA the same way. Doug Dutile explained that the state gives us unfunded mandates, and in some cases the precinct has had to obtain loans in order to comply with said mandates.
