Attendance: Doug Dutile, Mike Lavoie, Albie Estes, Barb Dutile and Mary Ann Rood

Approve Agenda: Motion to approve by Doug Dutile. Second by Mike Lavoie – all in favor

Approve prior meeting minutes: Motion to approve as printed by Mike Lavoie. Second by Doug Dutile – all in favor

Approve Manifest: reviewed and signed by commissioners

Old Business

Dan Baker: Doug Dutile, Mike Lavoie and the Fire chief went to the pre-trial conference. Doug explained that this was just a pre-trial. The judge scheduled the hearing August 21, 2024 at 10:00 am. All exhibits, witness lists and documents are due 14 days prior to trial.

New water meters: New meters are at Woodsville and ready to be installed. Admin will set up appointments once we hear from Harold.

Cybersecurity: A Primex representative came to assess our cybersecurity. It was suggested that we switch to .gov for security purposes. Commissioners need to vote on a switch to .gov. Motion to switch to .gov by Doug Dutile. Second by Albie Estes – all in favor

Pole at end of fire station driveway: Mike said that Scott said the power company will take care of it.

New Business

Treasurer's report: Presented by Barb Dutile. Unanticipated Funds \$28,673.75 / Water Account \$71,849.33 / Donations \$3,167.52 / Building Account \$112,580.65. Motion to approve as printed by Mike Lavoie. Second by Albie Estes – all in favor. Discussion regarding the trust fund. We received the check for the meters, but have not received the remaining money from the trust accounts to be closed and sent to the town. Will follow up.

Unregistered Vehicles: Mike Lavoie expressed concern regarding the inventory list we submitted to the town last fall and the fact that we have not received feedback. We have more to add to the list. Doug Dutile thinks we should send a letter to the town stating that we fulfilled our end of the assessment and they need to take care of it. The letter should reference the RSA. The town is responsible for enforcement. Mike asked the administrator to send a letter to the town for follow up

Public Hearing (Planning Board – Town of Haverhill) for Tuesday, May 28th. Admin presented the public hearing notice. Commissioners reviewed. Discussion

Other Business: Mike Lavoie stated that he heard back from Scott Eastman regarding the pole at end of fire station driveway. Scott said the power company will take care of it.

Mike Lavoie received a call about the water smelling at the Putnam's residence. We will monitor and if necessary, ask Woodsville to check it out.

Doug Dutile received two complaints, one regarding the red camp at 240 Mt. Moosilauke. They have added an addition. Second, Jim Bullock at 209 DCH is building a deck in back – both of these didn't seek permits. Doug will send Mark Locke (Town of Haverhill) an email to inform the town that permits were not issued. Discussion.

Mike Lavoie asked the planning board to provide minutes.
