

# TOWN OF HAVERHILL WOODSVILLE VILLAGE RAILROAD PARK

## Usage Rules and Regulations

This facility was constructed with 80% federal highway scenic byway funds and 20% taxpayer funds from the Town of Haverhill. It was built and is maintained for the cultural and recreational enjoyment of our citizens and visitors. Please follow these simple rules so that the Park may be enjoyed by all.

### PARK HOURS: DAWN TO DUSK

- No dogs or other pets may run free on Park grounds per Town Ordinance. Owners are required to clean up after their pets. No riding animals are permitted in Park.
- No overnight camping permitted.
- Parents or guardians are responsible for their children and must supervise them while in the Park.
- No organized ball games, hitting of golf balls or other games potentially hazardous to other Park users are permitted.
- **No trash containers are provided. What you bring in, please take out.**
- No alcoholic beverages or glass bottles permitted, no drugs, or weapons permitted.
- Pedestrians only within the fenced area. OHRV's permitted only on the State trail.
- Swimming in the rivers from this property is prohibited.
- No adults are permitted on the playground equipment.
- The bandstand is not for general public use.
- When using the walking path, please be courteous to others.
- All concerts or other performances must be arranged through the Town Recreation Department at 787-6096.
- Postings in the Kiosk must be approved, in advance, by the Town.

**ANYONE NOT FOLLOWING THESE RULES WILL BE GUILTY OF A VIOLATION PUNISHABLE BY A FINE NOT TO EXCEED \$ 100.00, FOR EACH OFFENSE, BY ORDER OF THE HAVERHILL BOARD OF SELECTMEN.**

THESE FEES MUST BE PAID AND THE INSURANCE BINDER RECEIVED BEFORE THE ACCEPTANCE OF THE APPLICATION.
